Information collected

When you use the **Englishplus** website we do not collect personal information about you unless you request a specific service using online forms and every time you email us your details. We use this information to:

- contact you to respond to your queries (if you email us with a question, for example)
- provide you with services (send you an email newsletter or enable your progress through an online course, for example)

Other than that we do not collect any personal information from you.

2. Use of cookies

Cookies are pieces of data that a website can transfer to an individual's computer hard drive for record keeping. 2.1 Google Analytics

We use Google Analytics to collect information about how our visitors use and navigate this website. We use this information to analyse usage of the website so that we can continually work to add new features and improve your experience of it.

The cookies collect information such as the number of visitors to the site, which pages they visited and whereabouts they came to the site from. This information is anonymous and cannot be used to identify you personally.
